

“Share Your Own Macau Story” Terms and Conditions

1. Eligibility:

All Macau residents or tourists aged 18 or above are eligible to participate in the activity, and each participant can submit only one entry. The Organiser reserved the right to disqualify any participant.

2. Submission of Entries:

- 1) Participants can enter the designated webpage of the activity to fill in personal information and upload photo and story content to submit the entry. The website address is <https://qr.sjm.mo/8mi1fl>
- 2) The file format of the photo must be jpg, jpeg, or png, with resolution at least 150 dpi, file size not exceed 5mb.
- 3) Content must meet the following conditions
 - a. must not contain discriminatory, controversial, or inappropriate words or meanings;
 - b. must not contain obscene, vulgar, violent, defamatory, or similar elements;
 - c. must not contain elements promoting commercial or political matters;
 - d. must be content that's created by the participant and never been published

3. Selected Participants:

Maximum 3 participants will be selected each month who will receive one Grand Lisboa Palace Art Gallery limited-edition gift.

4. Prize Collection:

Selected participants will be noticed by email to collect their prizes, prize is required to pick up within the specified time period at Grand Lisboa Palace Art Gallery.

5. Judging Panel and Criteria:

Judging panel will be made up of team members of Corporate Brand and Marketing of Grand Lisboa Palace.

Judging criteria listed as below:

- 1) Relevancy with the exhibition theme “The Lisboa: Stories of Macau”
- 2) Authenticity of the story
- 3) The presentation of the photo

- 2) Participants must agree to, accept, and comply with the activity rules and regulations. Any violation of the rules and regulations, if confirmed, may result in the disqualification of participation or awards. The organizer reserves all relevant rights to address any actions detrimental to the activity.
- 3) Participants are required to respect the decisions of the judging panel. Those with concerns should refrain from participating.
- 4) Participants are prohibited from requesting, influencing, enticing, threatening, or interfering with the judging panel or the judging process.
- 5) Selected authors agree to grant non-exclusive, royalty-free authorization to the organizer for exhibition purposes. The organizer may display photos of the winning entries, including the name of the authors accompanying artwork descriptions, or use the same to create audiovisual works (videos) and digital format files for public display, broadcast, and online viewing.
- 6) Participants will be disqualified if their entries are found to be involved in any of the following situations and the allegations are proven to be true, and all prizes received will be returned:
 - Selected authors are reported for plagiarism or violations of copyright or related laws, and a court judgment confirms the allegations.
 - Selected authors are reported or accused of not being original creations or of impersonating another person's work with concrete evidence. After verification by the judging panel, if it is deemed true, the award will be revoked.
 - If selected authors engage in requests, influencing, enticing, threatening, or other interference with the judging panel or the judging process, and the judging panel deems the behavior to be severe.

- 7) Participants agree to assume responsibility for any loss or damage to any person, property or right arising out of any of the circumstances referred to in the preceding clause and agree to indemnify, release and hold SJM Resorts, S.A. (including its directors, agents and employees) harmless from and against all liability, loss and damages in connection therewith.
- 8) The organizer reserves the right to change the event. For any matters not covered herein, the official website shall prevail. In the event of disputes, decisions made by the judging panel after deliberation will be final.
- 9) Should there be any discrepancy in Chinese and English versions, the Chinese version shall prevail.
