Customers must link their ICBC Visa card to ICBC e-payment and scan the code on-site at SJM's designated restaurants (hereinafter referred to as "Designated Restaurants") to receive a MOP 50 red packet. This red packet can be used for a single transaction with a net spending of MOP 300 or more at Designated Restaurants. The red packet must be used with ICBC e-payment and settled through the acquiring terminals provided by ICBC Macau. The net transaction amount refers to the amount paid by the customer using their own funds (hereinafter referred to as "Net Spending Amount");
3. Each ICBC e-payment customer may scan and receive a red packet a maximum of once per day. The next red packet can only be scanned and received after the previous one has been used.
